

## VSC MEETING SUMMARY

08-13-14

**Call to Order & Roll Call** Bob Stewart & Claude Hensley, VSC Co Chairs. *Attendance attached.*

**Past Action Items** Claude Hensley will report progress on Past Action Items

*Claude reported the automaker NASTF-SDRM page screenshots were up to date, including several changes since our last meeting. <http://www.lockmanlocksmiths.com/nastf-website-guides/>*

**SDRM Usage Report** David Lowell will report on a recent surge in interest/applications for Registry Membership. *David reported up to date Registry credential numbers: 1197 locksmiths. 850 mechanical, or collision repair technicians. 32 automaker / tech support. One reason for growing numbers is, Chrysler has limited their franchised dealers daily security data transactions; in a similar way to GM. The effect of this is to reduce likelihood that dealership log-in credentials will be used for code brokering, resulting in higher interest and use, for SDRM. David agreed to send the VSC co-chairs an up to date statistical power point, about two weeks before the semi-annual face to face meetings, for use in meeting preparation.*

**NICB Report** Ivan Blackman will update the VSC on the latest NICB matters related to the VSP Registry. *Ivan reported the numbers for thefts that were in a certain time window after the dissemination of a key code, either through a dealer or SDRM. He commented there were ongoing investigations regarding a number of those. NICB has passed relevant information to law enforcement as needed and referred LSID's to the SDRM Administrator for follow-up audits. David Lowell, reported following this segment that he has suspended 18 LSID's this year in connection with audits, whether random or requested by NICB or automakers.*

**NASTF Director Report:** *NASTF Director, Skip Potter reported he and David have implemented procedures to better screen Registry applicants and more effective audit practices, to be pro-active in making the Registry more secure.*

**Policy Work Group Update** Claude Hensley, VSC Co Chair will update the VSC on the latest activities of the PWG. *Claude reported there have been no proposed policy changes, so no PWG meetings were held.*

**SDRM Kaizen Opportunities** Claude Hensley will address kaizen initiatives currently being studied and/or already underway. *The most noteworthy Kaizen initiatives for 2014, are the improved procedures and practices mentioned in the NASTF Director report above.*

**Canadian SDRM Update** John Norris, National Automotive Trades Association (NATA) will update the VSC on Canada's SDRM activity. *John was unable to attend the call. We will outreach to John before our next meeting.*

**New Business** Bob Stewart will call for any new business items to be considered by the group. *Bob called for new business, but no attendees brought anything up.*

**Action Items** Bob Stewart will assign any new action items for VSC Committee Members as needed. *No new action items were assigned.*
